- ID
- Passport

2. Proof of San Francisco Residency. Such as:

- Rental or lease agreement
- Utility bill

3. Proof of Household Income. Such as:

- Pay stubs
- Tax return statement
- Award letters within the last 45 days

4. Proof of Assets. Such as:

- Bank statements within the last 45 days
- Most recent stocks/mutual fund statements, including those for retirement accounts
